The mark "excellent" is given to a student if, in the course of the interview, he shows exhaustive knowledge, consistently, clearly and logically harmoniously presents the material; uses additional material in the response; analyzes the results obtained; shows independence when performing tasks.

The mark "good" is given to a student if he firmly knows the material, expresses it competently and to the point, avoiding significant inaccuracies in answering the question.

The mark "satisfactory" is given to the student if, when answering the question posed, the student makes inaccuracies, insufficiently correct formulations, there are violations of the logical sequence in the presentation of the program material.

The mark "unsatisfactory" is given to a student if he makes significant mistakes, the necessary practical competencies are not formed.

2. Description of the grading scale

The maximum possible score for the entire current control is set equal to 55. The current control event is considered passed if the student received for it at least 60% of the maximum score set for this control. The rating score given to the student for the current control event, handed over by the student within the timeframe established by the control events schedule, is determined as follows:

1. Competency assessment criteria

The mark "excellent" is given to a student if he has deeply and firmly mastered the program material, expresses it exhaustively, consistently, clearly and logically harmoniously, knows how to closely link theory with practice, freely copes with tasks, questions and other types of application of knowledge, and does not find it difficult to answer when modifying tasks, uses the material of monographic literature in the answer, correctly justifies the decision made, owns versatile skills and techniques for performing practical tasks.

The mark "good" is given to a student if he firmly knows the material, presents it competently and to the point, avoiding significant inaccuracies in answering the question, correctly applies theoretical principles in solving practical questions and tasks, has the necessary skills and techniques for their implementation.

The mark "satisfactory" is given to a student if he has knowledge of only the basic material, but has not mastered its details, makes inaccuracies, insufficiently correct formulations, violations of the logical sequence in the presentation of the program material, has difficulty in performing practical work.

The mark "unsatisfactory" is given to a student if he does not know a significant part of the program material, makes significant mistakes, hesitantly, with great difficulty performs practical work.

The mark "passed" is given to the student if he has mastered the program material, knows how to link theory with practice, copes with tasks, questions and other types of application of knowledge, uses the material of monographic literature in the answer, correctly justifies the decision made, owns versatile skills and techniques for performing practical tasks ... In this case, the presence of inaccuracies in the presentation of the material is allowed. Also, the student may experience some difficulties when performing practical work.

The mark "not passed" is given to a student if he does not know a significant part of the program material, makes significant mistakes, does not perform practical work.

2. Description of the grading scale

Description of the grading scale

The rating assessment of the student's knowledge is not provided.

Intermediate control

Intermediate certification in the form of an exam provides for a mandatory examination procedure and is estimated at 40 points out of 100. If the student's rating score in the discipline at the end of the semester is 60, then the program automatically adds 32 bonus points and gives the grade "excellent". A student's positive answer on the exam is assessed by rating points in the range from 20 to 40 ($20 \leq S_{ex} \leq 40$), a score of less than 20 points is considered unsatisfactory.

The scale of correspondence of the rating score of the exam to the 5-point system

3. Methodological materials defining procedures for assessing knowledge, skills, skills and (or) experience of activities, characterizing the stages of formation of competencies

The procedure for conducting this assessment includes the selection and study of literature on the topic of the interview, a brief note-taking of the material studied.

The interview allows you to check the formation of competencies UK-5 - is able to perceive the intercultural diversity of society in socio-historical, ethical and philosophical contexts, PC-5 - is able to ensure the formation and implementation of corporate standards and regulations for service processes, compliance with industry service standards...

To prepare for this baseline assessment, it is necessary to prepare and submit monitoring results in the form of an article or report. When answering basic-level questions, the student must show fluency in basic terms and concepts.

To prepare for this advanced assessment activity, it is necessary to prepare and submit scientific report and presentation. RWhen revealing the content of questions of an advanced level, it is necessary to demonstrate an understanding of the essence of what is being stated.
